



TERMS AND CONDITION
of the Information Service of the Law Firm
SKP Ślusarek Kubiak Pieczyk spółka komandytowa

1. GENERAL PROVISIONS

- 1.1. This regulation set forth the terms and conditions for the use of the Information Service of the Law Firm SKP Ślusarek Kubiak Pieczyk spółka komandytowa (the "SKP"), which consists of the official website of SKP and thematic blogs (the "Website").
- 1.2. In all matters related to the operation of the Website, the SKP may be contacted by e-mail at biuro@skplaw.pl or by postal mail to the SKP's registered office address.
- 1.3. These Terms and Conditions are the fulfillment of the obligation referred to in Article 8 of the Act of July 18, 2002 on the provision of electronic services and are made available free of charge on the SKP website at www.skplaw.pl in a form that allows free recording, storage and reproduction by users of the Website.

2. RULES OF USE OF THE WEBSITE/SERVICE

- 2.1. All functionalities of the Website are made available free of charge to all users using the Internet. Everyone using the Website should familiarize himself/herself with the content of these Terms and Conditions.
- 2.2. Use of the Website by users constitutes acceptance of the provisions of these Terms and Conditions.
- 2.3. Use of the Website requires a computer or other device with access to the Internet, any web browser. For selected functionalities of the Website, it is necessary to have an active e-mail account and to be registered by the user.
- 2.4. Users are obliged to use the Website in a manner consistent with the content of these Terms and Conditions, respect for the law and observance of good morals. In particular,



it is forbidden to provide content of a nature that violates the law, to interfere with the operation of the Website, including its source code, to post viruses, trojans and other mechanisms that may have a negative impact on the operation of the Website, the SKP or Website users.

- 2.5. The SKP makes the following electronically provided services available on the Website:
- a) providing information about the SKP's law firm, the subject matter of its activities, the services it provides, as well as legal articles on the latest rulings, regulatory developments and other relevant information, and thematic podcasts;
 - b) providing the Newsletter registration form and Newsletter services;
 - c) providing users with access to thematic blogs on intellectual property law and others, and sending notifications of new articles within thematic blogs;
 - d) providing a contact form with the SKP.

3. NEWSLETTER SERVICE

- 3.1. The Newsletter service consists of sending for interested parties expert information: about court rulings in the field of IP law, decisions, draft legislation, national and European legislative initiatives, articles and columns written by the SKP lawyers, as well as information about upcoming events, events and training courses organized or co-organized by the SKP.
- 3.2. The Newsletter may contain commercial information within the meaning of Article 2 of the Act of July 18, 2002 on the provision of electronic services.
- 3.3. The Newsletter information shall be sent no more than 1 ("one") time per week.
- 3.4. You can sign up for the SKP's Newsletter by providing your e-mail address and accepting the Newsletter Regulations. A return message shall be sent to the e-mail address provided, with a request to confirm subscription to the Newsletter service.
- 3.5. The email address provided shall be used by the SKP solely for the purpose of sending the Newsletter.



3.6. You may unsubscribe from the Newsletter at any time by clicking the appropriate unsubscribe link provided at the end of each Newsletter message or by sending an email to biuro@skplaw.pl.

4. COMPLAINTS

4.1. The SKP makes every effort for the proper functioning of the Website and adaptation to the needs of users. Each user has the possibility to report objections, errors and other irregularities in the functioning of the Website by mail to the address of the SKP's headquarters or electronically to biuro@skplaw.pl.

4.2. Complaints should include a detailed description of the objections, errors or irregularities of the Website, as well as contact details enabling the SKP to respond to the complaint. In the event that it is impossible to investigate the complaint or respond, the SKP shall contact the user, if possible, requesting additional information or data in order to investigate the complaint.

4.3. The complaint shall be answered promptly, but no later than within 14 ("fourteen") days of receipt of the complaint or additional information, in accordance with Section 4.2 above.

5. PERSONAL DATA

6. FINAL PROVISIONS

6.1. These Terms and Conditions shall come into force on July 1, 2022.



- 6.2. These Terms and Conditions may be amended, provided that this does not violate the acquired rights of users. Amendments to the Terms and Conditions shall be published on the Website fourteen ("14") days in advance.
- 6.3. In matters not regulated by the provisions of the Terms and Conditions, the relevant provisions shall apply, in particular the provisions of the Act on Provision of Electronic Services and the provisions of the Civil Code.
